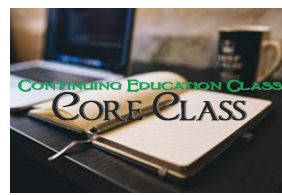

Online Classes with REcampus

You may receive an email from support@knowledgehub.com regarding your online courses with REcampus. If you have completed the course, no action is needed on your part. Should you still need to complete a course, you must complete it before the noted expiration date listed in the email.

Example email:

"We are sending this e-mail to inform you that your access to the course(s) listed below will expire soon. For each course you have not already completed, you will need to complete the course prior to expiration to receive a valid completion."

This is a courtesy email from REcampus notifying every student when their **course access** is expiring which is six months after date of purchase. After the expiration date, you cannot go back in to review.
